

Safety regulations at Falkvarv AB

All personal visiting Falkvarv's premises is required to report upon entry and are obliged to comply with the following regulations.

Falkvarv AB is obliged to follow the International Security Code ISPS. Unauthorized persons will be expelled from the area.

In addition to Swedish law, the "General conditions <u>AVR</u>", "General order regulations <u>SAFE-18</u>" and the "Safety regulations" below shall apply.

A. FIRE PREVENTION REGULATIONS:

1. Heat work:

Heat work must not be carried out without a special permit issued by the management in charge.

2. **Gas installations:**

The acetylene outlet backfire stop valves shall be mounted when in use.

At the end of the working day, the oxygen and acetylene gas valves shall be closed and hosepipes disconnected.

Alternatively, the stop valves could be closed and the hosepipes unrolled on open deck.

3. Regulations and directives regarding smoking:

Tobacco smoking is prohibited in connection with work operations where smoking could imply risk of accident or fire, and in places, which could contain gas or other inflammables.

Smoking is forbidden in all personnel rooms and in buildings where personnel and customers can be located. This also applies to e-cigarettes.

4. **General:**

In order to prevent fire, good order must be aimed at. Anything adding to the risk of fire shall wherever possible be removed from the work place.

Inflammable oils, paints, solvents and such shall be kept exclusively in closed and approved vessels.

Spillage shall always be wiped up immediately.

5. Fire extinguishing equipment:

The firefighting equipment shall be kept so as to be easily available and must under no circumstances be moved to other places.

Each time the fire extinguishing equipment has been used, a report shall be delivered to the foreman who promptly sees to it that the equipment is putt in order so as to be in working order if a new fire hazard arises.

B. HEALTH AND ACCIDENT DIRECTIONS:

1. <u>Personal protective equipment:</u>

It is forbidden to visit the yard area without a helmet.

Management has blue helmets, workers has white helmets and safety representatives has green helmets.

Fall protection equipment must be used.

First Aid Kit is available at strategic locations on the shipyard, such as in dock's, workshops and changing rooms.

2. **Scaffolding:**

Construction and alteration of scaffolding shall be controlled by staff with a thorough knowledge at its structure and safety aspects.

Guard railings shall be erected at open well stairs, hold hatches, manholes and other openings where there is a risk of false stepping, stumbling or falling.

3. <u>Electric lighting and installation:</u>

Taking on board, connecting and disconnecting and repairs of temporary electrical equipment of 24 V and 220 V on board a ship may be performed by a non-electrician provided the person in question has the knowledge and skills required for the job. Storage or repair shop staff performs repairs.

4. Turning of main engine:

Before turning of main engine during docking, contact the responsible foreman about work at the propeller.

5. Order regulations:

As seen from the point of view of accident and fire protection, it is necessary that good order should be maintained in the place of work.

Hosepipes and cables shall be connected as near to work place as possible.

Material in workshops and on board ships must not be placed so that corridors and passages are obstructed.

Remaining and discarded materials, package, wrappings and such like shall be removed as soon as possible.

Spillage of oil or paint shall be wiped up immediately.

Persons who do not hold a valid permit or a driver's licence where this may be required must not drive vehicles.

6. The parking of bicycles and motor vehicles:

Vehicles and bicycles shall unless special reasons can be adduced be placed in parking spaces respectively bicycle stands.

Under no circumstances, is it allowed to place them in such a way that they obstruct cranes, trucks, lorries and the distribution of materials.

7. **Staff rooms:**

It is duty of every person using the Falkvarv staff rooms keep the premises clean and tidy.

8. Chemicals

Information about approved chemical is available from the Environmental manager. It is **forbidden** to introduce or use chemicals that is not approved by Falkvarv AB

C. STEPS TO BE TAKEN IN CASE OF FIRE AND ACCIDENTS:

1. <u>Fire:</u>

The hand fire extinguisher equipment is intended for the extinction of minor fires. In case of serious accidents call **112** ask for the Fire brigade.

Anyone raising the fire alarm shall adequately indicate the site of the fire and shall when emergency vehicles arrive assist in directing them to the place and check that gates are open for entrance.

2. Accidents:

All accidents occurring on the job or on the way to and from the work place shall according to law be reporter as soon as possible to the employer. Should hospital treatment be required Falkenberg Health Centre is to be contacted directly, contact the office

If an Ambulance or Fire brigade is required call 112.

3. Collection point is outside the main gate, see Situation Plan.
